**ORDER**

Whereas name of Ms. Harpreet Kaur D/o Mohan Singh was recommended for appointment as Post Graduate Teacher in Punjabi Merit No. 23 by the Haryana School Teachers Selection Board, Panchkula vide letter No. 2/1/2013-HSTSB/2013/CA dated 20.03.2013. While recommending the names of selected candidates, the Haryana School Teachers Selection Board, Panchkula had made observations as under:-

*"The selected candidate has not been medically examined and no special enquiry into his/her antecedents has been made. The documents pertaining to his/her qualifications, 4 Year Experience, age, caste/category and Universities as claimed by him/her in the application form may please be got checked/verified from the issuing authorities, before he/she is allowed to join her duty. A copy of the appointment letter issued to the candidate may also be endorsed to the Board.*

2. As per recommendations made by Haryana School Teacher Selection Board, Panchkula, the appointment order was issued to Ms. Harpreet Kaur D/o Mohan Singh vide this office memo No 6/4-2013-HRL(4)/Punjabi on dated 14.12.2013 with the direction to join immediately in the office of Director SCERT, Haryana, Gurgaron. Subsequently the counseling was held for a number of times for allotment of the places of the postings on 19.01.2014, 20.01.2014, 05.02.2014 and 12.07.2014 but Ms. Harpreet Kaur D/o Mohan Singh has not appeared for the same. The report from Director SCERT, Haryana, Gurgaron has also been obtained and as reported, Ms. Harpreet Kaur D/o Mohan Singh has not joined in the office of Director SCERT, Haryana, Gurgaron.

3. Thereafter, a show cause notice was issued to her vide memo No. 6/4-2013 HRL (4) dated 22.10.2014 intimating why the recommendations for cancellation of the candidature in respect of Ms. Harpreet Kaur D/o Mohan Singh be not made to the appropriate authority. Reply, if any, she wants to file in response to this notice may reach the office of Director Secondary Education not later than 15 days from the date of the receipt of that notice. It was also mentioned that in case she failed to respond to the notice within a stipulated period, it shall be presumed that she has nothing to say/submit in this regard and decision will be taken ex-parte.

4. Now, after a considerable period of 08 month also, no response/reply in reference to said show cause notice has been received from Ms. Harpreet Kaur D/o Mohan Singh.

In view of the above, it is evident that she is not interested in joining as PGT Punjabi in School Education Department. Hence, the offer letter for appointment issued to her earlier is hereby withdrawn and her candidature for the post of PGT Punjabi is hereby recommended to be cancelled to Haryana Staff Selection Commission, Panchkula.
